Subject: TANF Pandemic Emergency Fund

This memorandum responds to your request for alternative estimated allocations to the states for a TANF Pandemic Emergency Fund. It compares estimated allocations under the "Chairman's Mark" for the House Ways and Means Committee budget reconciliation legislative package, released by Committee Chairman Richard Neal on February 8, 2021¹ versus an allocation based on the number of children in poverty in the state.

These estimates are provided solely to assist in comparisons of the relative impact of alternative formulas and funding levels in the legislative process. The data used in providing the allocation estimates is discussed in the note to the tables. Should the Department of Health and Human Services (HHS) use different data, the allocations to the states would likely also differ. Additionally, the Congressional Research Service (CRS) may use this information to respond to similar requests from other Congressional offices. Your request to us will remain confidential.

The estimates of the allocation based on child poverty assume that the "set-asides" for technical assistance (\$2 million) and tribes and territories (7.5% of funds remaining after the technical assistance set-aside) that are contained in the "Chairman's Mark" are also used in the alternative formula. The data on number of children (persons under age 18) living in families with income below the poverty threshold are estimates from the U.S. Census Bureau's American Community Survey for 2019.

Table 1 shows the estimated allocations under the two alternatives. **Table 2** shows the allocations of the alternatives as a percent of the TANF State Family Assistance Grant, thus reflecting the relative increase that the two Pandemic Fund alternatives would provide above current law TANF funding.²
