Inspector General Grimm,

We request that the Office of Inspector General (OIG) immediately open an investigation into the Unaccompanied Alien Children (UAC) program administered by the Department of Health and Human Services (HHS), within the Administration for Children and Families' Office of Refugee Resettlement (ORR). We are concerned about ORR's response to the recent upsurge in unaccompanied children arriving at the southwest border, and the protocols employed for placing unaccompanied children in facilities designated as state-licensed foster care placements, increasing pressure on an already overburdened U.S foster care system.

In 2023, the Customs and Border Patrol reported a staggering influx of over 137,628 unaccompanied children crossing the border which reflects an 83 percent increase compared to 2019. The peak of this surge occurred in August, with an unprecedented 14,259 unaccompanied children crossing in a single month.

Governors and state leaders across the country have raised alarms about the Biden Administration's efforts to find housing for unaccompanied alien children by aggressively recruiting from limited foster homes available to provide safe and loving homes to the nearly 400,000 children and youth in America's child welfare system. ³⁴ Governor Pete Ricketts (R-NE),

Governor Kristi Noem (R-SD), Governor Kim Reynolds (R-IA), and Governor Henry McMaster (R-SC) have all publicly declined the Administration's requests due to existing pressures on the foster care system. Governor Ricketts said his state would be "declining [the administration's] request because we are reserving our resources for serving our kids."⁵

A recent Fox News article highlighted the growing strain the border crisis is placing on the U.S foster care system as increasing numbers of unaccompanied children who arrived without parents or were separated at the border are competing for scarce placements with U.S. children. According to HHS, as of August 2023, there were 7,800 unaccompanied children in care and the average length of time an unaccompanied child remained in ORR care was 27 days.

Adding to the urgency of the situation, a February 2024 report from your agency titled "Gaps in Sponsor Screening and Follow-up Raise Safety Concerns for Unaccompanied Children" sheds light on the challenges exacerbated by these drastic increases. The report underscores ORR's failure to properly vet, place, and maintain proper placements of unaccompanied children. The report revealed that in 22 percent of cases, ORR neglected to conduct timely safety and well-being follow-up calls, and, in 18 percent of cases, these critical calls were never completed. Such findings underscore the systemic deficiencies within ORR, indicating a lack of capacity to adhere to essential protocols for caring for unaccompanied children and protect limited taxpayer dollars.

We are seriously concerned about the ability of ORR to manage the UAC program and the "crowding out" effect the surge in unaccompanied children is having, including potentially devastating consequences for children in foster care already experiencing trauma as a result of neglect or abuse.

The U.S. foster care system is already in a state of crisis. There is a nationwide shortage of foster homes, as our Committee recently pointed out in a letter to HHS documenting a decline in foster homes and state challenges recruiting foster placements. Since 2018, there has been an average decline of six percent of available foster parents each year, with some states, such as South Carolina, reporting a 61 percent decline in licensed foster homes despite a growing number of children entering care. The COVID-19 pandemic only further strained these limited resources, resulting in a decline in licensed foster parents and an increased demand for child welfare services. This shortage has resulted in American children sleeping in jails, emergency rooms, caseworker offices, hotels, and other unlicensed placements. Federal and state resources are limited, and states are working tirelessly to expand their capacity to support the children already in their care. The

surge of unaccompanied children at the border is compounding these challenges, diverting vital resources—shelters, foster parents, and state workers—due to an uncontrolled border.

We request the OIG conduct a thorough investigation and provide findings to the Committee regarding the impact of placements of unaccompanied children on the U.S. foster care system. The investigation should focus on addressing the following specific points:

- Review ORR contracting practices with non-profit and community-based organizations, exploring their impact on the displacement of children in foster care.
- Assess the burden placed on state child welfare agencies in placing foster children due to ORR contracting, considering various placement settings, including foster parents, group homes, residential care facilities, and supervised independent living, particularly in states with high numbers of migrant children.
- Investigate and examine the degree to which state monthly foster care payments, and federal foster care maintenance payments authorized by Title IV-E of the Social Security Act, are comparable to those rates provided through ORR federal contracts to reimburse providers for placement of unaccompanied children.
- Report on the number of state-licensed foster care parents and providers who are caring for unaccompanied children.
- Review the number of unaccompanied children that come into the long-term care of the state when a sponsor cannot be located and the impact of those long-term placements on state child welfare agencies.

We request that the agency provide a response to the Committee with an initial timeline related to these questions no later than **March 30**, **2024**.
