A BILL

To amend title XVIII of the Social Security Act to modify the distribution of certain additional graduate medical education positions under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Rural Physician Work-
5 force Preservation Act”.

1 **SEC. 2. MODIFYING THE DISTRIBUTION OF CERTAIN ADDI-**
2 **TIONAL GRADUATE MEDICAL EDUCATION PO-**
3 **SITIONS UNDER THE MEDICARE PROGRAM.**

4 Section 1886(h) of the Social Security Act (42 U.S.C.
5 1395ww) is amended—

6 (1) in paragraph (9)—

7 (A) in subparagraph (B)(ii)(I), by amend-
8 ing such subclause to read as follows:

9 “(I) Hospitals that—

10 “(aa) are located in a rural
11 area (as defined in section
12 1886(d)(2)(D)); or

13 “(bb) are treated as being
14 located in a rural area pursuant
15 to section 1886(d)(8)(E), but
16 only if such hospital so treated
17 meets a criterion specified in sub-
18 clause (I) or (II) of clause (ii) of
19 such section.”; and

20 (B) in subparagraph (F)(ii), by inserting
21 “and includes, with respect to the distribution
22 of full-time equivalent residency positions for
23 fiscal year 2023 or 2024, a hospital that is
24 treated as being located in a rural area pursu-
25 ant to section 1886(d)(8)(E) regardless of
26 whether such hospital meets a criterion speci-

1 fied in subclause (I) or (II) of clause (ii) of
2 such section” before the period; and

3 (2) in paragraph (10)(B)(ii)(I), by amending
4 such subclause to read as follows:

5 “(I) Hospitals that—

6 “(aa) are located in a rural
7 area (as defined in section
8 1886(d)(2)(D)); or

9 “(bb) are treated as being
10 located in a rural area pursuant
11 to section 1886(d)(8)(E), but
12 only if such hospital so treated
13 meets a criterion specified in sub-
14 clause (I) or (II) of clause (ii) of
15 such section.”.
